Bartender Fee of \$400 for first 150 guests;

Pricing: beer & wine beverages are \$5 each and mixed drinks are \$9-10 each.

Tab-to-Cash Bar

\$250 Minimum Tab

You determine the amount you would like to spend (limit), should the tab reach your limit there is the option to resume bar service as a cash bar. This is viewed as a "limited open" bar to your guests.

Tab Bar

Should you choose to pay the **full tab** without switching to a cash bar, this is viewed as an "open" bar to your guests.

Cash & Credit Cards are accepted via Square Register.

You pay the amount that is tallied on the tab and the amount is due at the conclusion of the event to the bartender. We do not bill afterwards; you must pay at the conclusion of the bar service.

There is 9% (F&B) tax on all beverages. There is no gratuity added to the tab and we cannot accept card tips, we recommend tipping your bartender cash or via their cash app!

Event & Wedding Packages include 1 bar station with 1 bartender. Individual Room Rentals require a bartender fee. No bar service can exceed 5 hours. We require the bar to close 30 minutes prior to the event's end.

Multiple bars (i.e. cocktail hour in separate room or bar stations for 150+ guests) result in an additional bar service fee. Additional bartenders are required for over 150 guests; thereafter 1 Bartender per 100 guests.

Clients, other than non-profit organizations, are required to use only SkyView's Bar Services. Clients may not bring their own alcoholic beverages, hire an outside bar service, or use a caterer's bar service. **There is a \$500 fine if outside alcohol is brought onto the premises.** Non-Profit Organizations who opt out of SkyView's Bar Services are required to pay a \$75 fee and must obtain an ABC Special Occasion Permit.

Contact a manager for inventory selections, prices and menu suggestions. We prefer to finalize your menu at your final details meeting, 30 days prior to the event. Menu must be finalized no later than 14 days prior to the event date. Venue reserves the right to make substitutions. We do not serve shots or frozen blended drinks. We serve only 1 drink per person at a time. We ID!
